The general nature of the proposed works is as follows:----

- (i) construction of a proposed footbridge extension and the associated columns linking the public housing development at Choi Yuen Road Sites 3 and 4 and the existing footbridge;
- (ii) permanent closure and conversion of sections of the existing cycle track into footpath and cycle parking area;
- (iii) permanent closure and conversion of sections of the existing car park into cycle track and cycle parking area;
- (iv) permanent closure and conversion of sections of the existing cycle parking area into cycle track;
- (v) temporary closure and reconstruction of a section of the existing footbridge for connecting to the proposed footbridge extension;
- (vi) temporary closure and reconstruction of a section of the existing cycle track;
- (vii) temporary closure and reconstruction of a section of the existing cycle parking area;
- (viii) temporary closure of sections of the existing carriageway, footpath and footbridge; and (ix) ancillary works including drainage, public lighting facilities and landscaping works.
