

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1419EM17T—Triennial Contract for the Maintenance of Town Gas Installations at Various Venues of Transport, Security and Central Services Division**. The scope of works includes inspection, maintenance, testing, repair and replacement of town gas installations, including equipment, appliances, pipework and associated accessories, at various venues of Transport, Security and Central Services Division. The Contract Period is 36 months and the Contract is scheduled to commence in August 2017.
