

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1423EM17T, Biennial Term Contract for the Comprehensive Maintenance and Repair of Lift Installations at Various Premises of Hospital Authority (SC 17)**. The scope of Works includes the maintenance and repair of lift installations in various premises of the Hospital Authority. The Contract Period is 24 months and the Contract is scheduled to commence in September 2017.

1. A Tenderer must be a registered lift contractor under the Lifts and Escalators Ordinance (Chapter 618 of the Laws of Hong Kong); and
2. A Tenderer must have completed Lift maintenance contracts in or outside Hong Kong within the past 5 years with the minimum accumulated awarded contract sum of not less than HK\$6 million.
