

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. TD 47/2016—Telecommunication Services for On Street Traffic Signal Control and Related Equipment**. The scope of service includes provision of telecommunication links for a 5-year service period for the transmission of control signals between traffic control centres and the traffic light controllers around 1190 locations on-streets. The service is scheduled to commence in October 2017 for completion in September 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 16 June 2017. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 16 June 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered.
