It is hereby notified that tenders are invited for Contract No. HY/2023/08—Central Kowloon Route—Remaining Works (Public Works Programme Item No. 461TH). The works mainly include:—

- (a) design and construction of landscaping works at Yau Ma Tei Landscaped Deck, Yau Ma Tei Rest Gardens, North Tree Park and Kai Tak Phase 2B Landscaped Deck;
- (b) improvement of a section of Kai Fuk Road of approximately 300 m in length;
- (c) planting of compensatory trees; and
- (d) associated civil works, electrical and mechanical works, road and drainage works, lighting works and establishment works.

The works are scheduled to commence in August 2024 and will take about 46 months to complete.
