

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 7/LANDS/24—Routine Maintenance Works for Lands Department Slopes in the Southern Regions**. The works mainly comprise routine maintenance of about 8 000 slopes and retaining walls maintained by Lands Department in the Southern Regions covering Hong Kong Island, Kowloon, Tsuen Wan, Kwai Tsing, Sai Kung, Lantau and the Outlying Islands Districts. The works are scheduled to commence in June 2024 and will take about 39 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 503, 5/F, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 15 March 2024. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted.

If a tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 15 March 2024, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 15 March 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors will be liable to have their names removed from the approved list if they fail or refuse to implement an accepted tender.
