# LIST OF CHARGES

- 1.1 A list of charges payable at Government polyclinics, clinics, dispensaries and other institutions with effect from 1 April 2003 is given below.
- 1.2 Patients falling into the following categories are eligible for the rates of charges applicable to the Eligible Persons:—
  - (i) a holder of Hong Kong Identity Card issued under the Registration of Persons Ordinance;
  - (ii) children who are Hong Kong residents and under 11 years of age;
  - (iii) other persons approved by the Director of Health.
- 1.3 For other patients, the rates of charges applicable to the Non-eligible Persons will apply. The Director of Health will determine the eligibility of patients to whom the rates of charges will apply.
- 1.4 The Director of Health has powers to require a deposit of part or the whole of the fees likely to be incurred by any patient.
- 1.5 Unless otherwise specified or agreed by the Director of Health, all charges specified in this notice are payable in advance or on demand by the Director of Health.
- 1.6 The Director of Health has powers, in his discretion to waive, reduce or remit the whole or any part of the fees chargeable at any institution under his control or for the service of a Consultant or a Medical Officer outside a Government institution.

## CHEST RADIOGRAPHIC SURVEYS

- 6 (A) A fee of \$88 per person is charged for Chest radiographic surveys or examinations.
  - (B) No charge is made for the examination of patients attending the Government Tuberculosis and Chest clinic.

Notes:—

- (1) All films remain to be the property of the Government of the Hong Kong Special Administrative Region but they will be made available on loan to the medical practitioner attending the case on application to the Consultant Chest Physician i/c of the Tuberculosis and Chest Service.
- (2) When an X-ray examination has to be repeated due to some technical failure, or for further views in the same area before a diagnosis can be arrived at, there will be no extra charge.
- (3) When an X-ray examination has to be repeated in order to verify the progress of the patient, the charge will be half the original charge.

## LABORATORY SERVICES

#### Notes

- 7.1 (1) Request forms in duplicate should be properly filled in and signed. Full particulars of the examinations required, the nature of specimen submitted and brief clinical notes are required. These requests should be addressed to the Consultant Pathologists, Department of Health. Unless otherwise specified or agreed by the Consultant Pathologists, all charges specified below are payable in advance or on demand.
  - (2) The Consultant Pathologists may refuse any sample.
  - (3) Samples submitted for examination will remain the property of the Government and may be disposed of in any way considered suitable by the Consultant Pathologists.
  - (4) Government will not recognize any claims arising from the results of any examination.
  - (5) Other special tests not listed below will be determined by the Consultant Pathologists according to the actual cost of the test.
  - (6) Specimens for laboratory testing must be referred from registered medical practitioners.

- 8 (A) No charge is made for attendance at the following clinics having maternity wards:—

  Peng Chau Clinic
  - (B) For certificates issued in connection with the fitness or unfitness of patients or others to perform their duty, no charge is made. For certificates and medical reports for insurance and other purposes and for post-mortem reports, a charge from \$510-\$3,040 will be made. Full payment must be made at the time the certificates or medical reports are requested. No refund of the charges for certificates or medical reports will be made if the request is withdrawn before the certificates or medical reports are issued. The charge will be determined by the attending medical officer or consultant preparing the report. If a further examination is required before a certificate can be issued, the normal consultation fee will be charged in addition.
  - (C) For examination by the Medical Examination Board (including X-ray of chest with the right to retain the negative) and the issue of a certificate of fitness or unfitness, an inclusive charge of \$705 will be made.
  - (D) For personnel radiation monitoring service, the following fees will be charged:—

(i) Dosemeter cum holder

(ii) Personnel radiation manitaring services per person per year

- (E) For the services of a Government consultant or a medical officer outside a Government institution, the normal fees for consultations plus an addition of 50% will be charged.
- (F) For the issue of a detailed transcript of the course of training for a member of the Nursing grade in ex-Government hospitals and clinics, required for employment or training purposes in other hospitals or institutions, a charge of \$385 will be made for each transcript.
- (G) When a private medical practitioner requires a duplicate copy of an X-ray film, a charge of \$230 will be made for each copy. When such copies are required prior notification must be given. The Director of Health reserves the right to refuse any request for such duplicate copies at his discretion.
