

**ELECTORAL AFFAIRS COMMISSION (NOMINATIONS ADVISORY COMMITTEES  
(ELECTION COMMITTEE)) REGULATION (Chapter 541H)**

Pursuant to sections 3(2), (3) and (5), 4(3) and (4), 6(4) and (5) and 7(3) of the Electoral Affairs Commission (Nominations Advisory Committees (Election Committee)) Regulation, the following notices are given:—

**I. Appointment of Nominations Advisory Committees (Election Committee)**

The following legal practitioners are each appointed as a Nominations Advisory Committee (Election Committee) ('NAC(EC)') for the period from 19 August 2011 to 28 November 2011, both dates inclusive, in relation to the Election Committee subsector ordinary elections which will be held on 11 December 2011 and the nominations for the religious subsector, both with the nomination period from 8 November 2011 to 15 November 2011 for (a)(i) the non-District Councils Subsectors ('non-DCs subsectors') of the Election Committee Subsector Elections ('ECSS Elections') and (ii) the religious subsector; and (b) from 18 November to 24 November 2011 for the District Councils Subsectors ('DCs subsectors') of the ECSS Elections:—

Mr. HO Bing-kwan,  
Mr. LUI Kit-ling, and  
Mr. WONG Ching-yue, S.C.

**II. Periods in which each NAC(EC) must perform its functions**

Each NAC(EC) is to perform during the following periods the functions specified:—

- (a) Between 19 August 2011 and 9 November 2011, to perform functions on applications to seek advice by (i) prospective candidates of non-DCs subsectors and nominees, and (ii) designated bodies of the religious subsector;
- (b) Between 19 August 2011 and 21 November 2011, to perform functions on applications to seek advice by prospective candidates of DCs subsectors of ECSS.
- (c) Between 8 November 2011 and 17 November 2011, to perform functions on applications regarding (i) prospective candidates of non-DCs subsectors and nominees, and (ii) designated bodies of the religious subsector to seek advice by Returning Officers;
- (d) Between 18 November 2011 and 28 November 2011, to perform functions on applications regarding prospective candidates of DCs subsectors of ECSS to seek advice by Returning Officers.

**III. Periods in which applications for advice from the NACs(EC) are to be made**

- (a) Applications under II(a) must be made in the specified form; lodged with the Chief Electoral Officer either in person or by post or by facsimile transmission and to be received by him between 19 August 2011 and 7 November 2011, both dates inclusive;
- (b) Applications under II(b) must be lodged with the Chief Electoral Officer *via* the methods mentioned in paragraph III(a) above and to be received by him between 19 August 2011 and 17 November 2011, both dates inclusive.
- (c) Applications under II(c) must be lodged with the Chief Electoral Officer in writing and to be received by him between 8 November 2011 and 16 November 2011, both dates inclusive;
- (d) Applications under II(d) must be lodged with the Chief Electoral Officer in writing and to be received by him between 18 November 2011 and 25 November 2011, both dates inclusive.
