CASTLE PEAK ROAD TRUNK SEWER

(Notice under section 8(2) of the Roads (Works, Use and Compensation) Ordinance
as applied by section 26 of the
Water Pollution Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plans Nos. PM/CPRTS01, PM/CPRTS02 and PM/CPRTS03 (the 'Plans') and described in the scheme annexed thereto, which Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of about 3 000 metres of sewer and associated manholes within the limit of works area as shown on the Plans;
- (ii) construction of about 1 100 metres of twin sewage rising mains;
- (iii) construction of Lok Chui Street Sewage Pumping Station and Siu Lam Psychiatric Centre Sewage Pumping Station; and
- (iv) ancillary works including temporary closure and reinstatement of roads, alleys, footpaths and open spaces.

The Plans and the scheme may be inspected by members of the public, free of charge, at the following locations during the following hours when those offices are normally open to the public:—
