AIR POLLUTION CONTROL ORDINANCE (Chapter 311)

(Decision made by the Air Pollution Control Appeal Board under section 33)

TAKE NOTICE that the Air Pollution Control Appeal Board (the ‘Appeal Board’) conducted a hearing on 8 April 2013 of an appeal (Appeal Case No. 2 of 2013) against the order (the ‘Order’) made by the Director of Environmental Protection on 18 January 2013 under section 67 of the Air Pollution Control Ordinance (Chapter 311) (the ‘Ordinance’) and published in G.N. 959 of 2013 (at Annex 1) on 22 February 2013 and confirmed the findings by the Asbestos Administration Committee (as set out in the first paragraph of G.N. 959 of 2013 at Annex 1).

TAKE NOTICE that pursuant to section 33 of the Ordinance, the Appeal Board made an order on 22 April 2013 to vary the Order such that (a) the name of Mr. LO Kwok Fai shall be removed from the register of asbestos supervisors for 15 months from 1 March 2013 to 31 May 2014 (both dates inclusive); (b) Mr. LO Kwok Fai shall be reprimanded; and (c) the findings and the said order of the Appeal Board made under section 33 of the Ordinance shall be published in the *Gazette*. The Appeal Board made no order as to the costs of the appeal.

AIR POLLUTION CONTROL ORDINANCE (Chapter 311)

(Order under section 67)

TAKE NOTICE that the Asbestos Administration Committee conducted a disciplinary inquiry on 13 December 2012 and was satisfied that Mr. LO Kwok Fai had committed neglect or misconduct referred to in section 62 of the Air Pollution Control Ordinance namely that, on or about 25 November 2011, being the registered asbestos supervisor responsible for the asbestos abatement work at R/F of Sunciti Building, No. 64 Hung To Road, Kowloon, failed to ensure that the asbestos abatement work complied with the requirements of the Code of Practice on Asbestos Control—Safe Handling of Low Risk Asbestos Containing Material.

TAKE NOTICE that pursuant to the authorization by the Authority under section 4 of the Ordinance and in the exercise of the powers under section 67 of the Ordinance, I have made an order that the name of Mr. LO Kwok Fai be removed from the register of asbestos supervisors for 24 months from 1 March 2013 to 28 February 2015 inclusive, and Mr. LO Kwok Fai be reprimanded and that the findings of the Asbestos Administration Committee and the said order made under section 67 of the Ordinance be published in the *Gazette*.
