SEWERAGE AT TSEUNG KWAN O VILLAGE, BOON KIN VILLAGE  
AND WO TONG KONG

(Amendment to Plan and Scheme under section 7)

(Notice under section 8(2) of the Roads (Works, Use and Compensation)  
Ordinance as applied by section 26 of the Water Pollution  
Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to amend the sewerage works originally described in the scheme and the Plans No. 382828/WPCR/1.1/001 to 003 and Resumption Plan No. SKM8057c referred to in G.N. 414 and G.N. 1162 published under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation on 25 January 2013 and 1 February 2013, and 1 March 2013 and 8 March 2013, respectively.

Take further notice that the Director of Environmental Protection proposes to execute the amendment sewerage works as shown on Plans No. 382828/WPCR/1.1/001A, 382828/WPCR/1.1/003A and Resumption Plan No. SKM8057e (the 'Amendment Plans') and described in the amendment scheme annexed thereto, which Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature of the amendment sewerage works is as follows:—

- (i) revisions of the limit of works area as shown on the Amendment Plans;
- (ii) deletion of the proposed land resumption of Lot Nos. 155 (Portion), 317 S.X (Portion), 317 S.Y (Portion), 317 S.Z (Portion) and 317 RP (Portion) all in D.D. 239 as shown on the Amendment Plans; and
- (iii) change in the area of proposed land resumption of Lot No. 335 (Portion) in D.D. 239 as shown on the Amendment Plans.
