

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
AS APPLIED BY SECTION 26 OF THE

PWP ITEM NO. 4362DS—SEWERAGE FOR MA YAU TONG, TSEUNG KWAN O
(Amendment to Plan and Scheme under section 7)
(Notice under section 8(2) of the Roads (Works, Use and Compensation)
Ordinance as applied by section 26 of the Water Pollution
Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to amend the sewerage works originally described in the scheme and the Plans No. 382828/WPCR/1.2/001 and 002 and Resumption Plan No. SKM8058e referred to in G.N. 688 published under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation on 8 February 2013 and 15 February 2013.

Take further notice that the Director of Environmental Protection proposes to execute the amendment sewerage works as shown on Plan No. 382828/WPCR/1.2/001A and Resumption Plan No. SKM8058f (the 'Amendment Plans') and described in the amendment scheme annexed thereto, which Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature of the amendment sewerage works is as follows:—

- (i) revisions of the limit of works area as shown on the Amendment Plans;
- (ii) addition of the newly proposed land resumption of Lot Nos. 326 S.A (Portion), 326 S.B (Portion), and 327 RP (Portion) all in D.D. 401 as shown on the Amendment Plans; and
- (iii) deletion of the proposed land resumption of Lot Nos. 226 (Portion), 229 (Portion), 237 (Portion), 305 RP (Portion), 324 RP (Portion), 326 RP (Portion), 326 S.C (Portion) and 436 (Portion) all in D.D. 401 as shown on the Amendment Plans.
