Annex 1

BACKGROUND

The works under the sub-contract comprise:—

- (a) the supply and installation of a central ACMV system comprising three (3) water-cooled chillers with a total cooling capacity of about 1 900 kW for the commercial centre and mechanical ventilation installation for the commercial centre, semi-basement carpark and Refuse Collection Point (RCP) at Tuen Mun Area 54 Site 2 Phases 1 and 2; and
- (b) the maintenance of the same for 24 months following the certified sectional completion date of the Building Works.

PRE-QUALIFICATION CRITERIA

- (a) Contractors applying for pre-qualification shall:—
 - (i) be on the Development Bureau's List of Approved Suppliers of Materials and Specialist Contractors of Public Works—Air-conditioning Installation (DEVB List AC—Group II) with 'Confirmed' status;
 - (ii) have local experience in the installation, testing and commissioning of ACMV installation with central chiller plant completed with acoustic treatment and not less than 2 200 kW cooling capacity in the past seven (7) years Note 1;
 - (iii) be with less than 10% 'Adverse' reports for all their current and completed HA projects in the past one year $^{\text{Note 2}}$;
 - (iv) be with less than 10% 'Adverse' reports for all their current and completed HKSAR Government projects in the past one year Note 2;
 - (v) not being restricted or suspended from tendering or removed from the DEVB List AC—Group II with 'Confirmed' status when being considered for admission to the pre-qualified tenderers list and at the time of tendering; and
 - (vi) have achieved ISO 9001 certification covering ACMV installation.
- (b) In addition to regular financial vetting by the Development Bureau, Hong Kong Housing Authority will conduct financial evaluation on the tenderers in respect of minimum capital ratio requirement Note 3; and
- (c) Joint ventures will not be considered in this tender.

INVITATION FOR PRE-QUALIFICATION

- (a) For related companies, only one of these companies is allowed to submit a tender for each tender. Companies are deemed to be related if their relationship falls within the meaning of 'related parties' as defined in the Hong Kong Institute of Certified Public Accountants (HKICPA)—Hong Kong Accounting Standard (HKAS24 (Revised)), on Related Party Disclosures.
- (b) The contractors will be required to confirm their compliance with 'related company restriction' when accepting pre-qualification invitation.

Note 3 Contractors shall have Employed Capital being no less than 10% of Total Assets.
