TAKE NOTICE that under powers delegated by the Chief Executive of the Hong Kong Special Administrative Region, I have made an order under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) (hereinafter referred to as 'the Ordinance') as applied by section 26 of the Water Pollution Control (Sewerage) Regulation that the roads, footpaths and open spaces or parts thereof within the limit of works area as shown Plans No. 3912/GAZ/002-2A, 3912/GAZ/003-2A, 3912/GAZ/004-2B, 3912/GAZ/005-2 and 3912/GAZ/006-2 (the 'Plans') and described in the scheme annexed thereto, which Plans and scheme were referred to in G.N. 2469 published on 18 April 2008 and 25 April 2008 shall be temporarily closed. I have further declared under section 17(1)(c) of the Ordinance that as from 7 February 2014 to 30 June 2015, all public or private rights in, upon, under or over the roads, footpaths and open spaces or parts thereof to be temporarily closed, shall be extinguished, modified or restricted, as the ease may be, during that period.

The sewerage works to be carried out in association with this closure involve:—

- (i) construction of about 500 metres of sewer and associated manholes within the limit of works area as shown on the Plans; and
- (ii) ancillary works including temporary closure and reinstatement of roads, alleys, footpaths and open spaces.
