(Amendment to Plans and Scheme under section 7)

(Notice under section 8(2) of the Roads (Works, Use and Compensation)
Ordinance as applied by section 26 of the Water Pollution
Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to amend the sewerage works originally described in the scheme and Plan Nos. 382770/WPCR/2.5/001 to 382770/WPCR/2.5/007 and Resumption Plan No. SKM8296 referred to in G.N. 3486 published under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation on 21 June 2013 and 28 June 2013.

Take further notice that the Director of Environmental Protection proposes to execute the amendment sewerage works as shown on Plan Nos. 382770/WPCR/2.5/001A to 382770/WPCR/2.5/006A and Resumption Plan No. SKM8296a (the 'Amendment Plans') and described in the amendment scheme annexed thereto, which Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature of the amendment sewerage works is as follows:—

- (i) revision of the project title as shown on the Amendment Plans;
- (ii) revisions of the limit of works areas as shown on the Amendment Plans;
- (iii) addition of newly proposed land resumption of Lots Nos. 461 (Portion), 479 (Portion), 562 S.A RP (Portion) and 562 RP (Portion) all in D.D. 253 as shown on the Amendment Plans;
- (iv) deletion of proposed land resumption of:
Lots Nos. 25 S.A (Portion), 31 RP (Portion), 158 S.E (Portion), 168 RP (Portion), 170 S.B (Portion), 191 S.A (Portion), 191 RP (Portion), 193 (Portion), 199 S.A ss.1 (Portion), 312 S.B (Portion), 312 RP (Portion), 313 RP (Portion), 700 (Portion), 701 (Portion), 705 S.A (Portion), 708 (Portion), 712 (Portion), 732 (Portion), 733 S.A (Portion), 733 RP (Portion), 738 (Portion), 739 (Portion), 749 (Portion) all in D.D. 226;

- (v) change in the area of proposed land resumption of:
Lots Nos. 29 (Portion), 32 (Portion), 36 (Portion), 194 (Portion), 219 S.A ss.1 RP (Portion), 229 (Portion), 243 RP (Portion), 307 RP (Portion), 432 (Portion) and 776 RP (Portion) all in D.D. 226;
Lots Nos. 363 RP (Portion), 529 S.B (Portion) and 529 RP (Portion) all in D.D. 253
as shown on the Amendment Plans;
- (vi) length of gravity sewers within the limit of works area is revised from about 5000 metres to about 4300 metres as shown on the Amendment Plans;
- (vii) length of twin pressurized mains within the limit of works area is revised from about 400 metres to about 270 metres as shown on the Amendment Plans; and
- (viii) deletion of a proposed sewage pumping station within the limit of works area as shown on the Amendment Plans.
