STAGE 3 INFRASTRUCTURE WORKS FOR DEVELOPMENTS

AT THE SOUTHERN PART OF THE FORMER RUNWAY

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. 60022408/S3/1.1 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) widening and re-alignment of Cheung Yip Street of approximately 330 metres (m) long, with associated footpaths and supporting underground structures;
- (ii) widening of Shing Cheong Road of approximately 410 m long, with associated footpaths and supporting underground structures;
- (iii) construction of central medians/traffic islands and pedestrian crossings;
- (iv) permanent closure and conversion of sections of the existing carriageways into footpaths, central medians/traffic islands or pedestrian crossings;
- (v) permanent closure and conversion of sections of the existing footpaths into carriageways, central medians/traffic islands or pedestrian crossings;
- (vi) permanent closure and conversion of sections of the existing central median/traffic island into carriageway or footpath;
- (vii) permanent closure and demolition of sections of the existing carriageway, footpaths and central median/traffic island;
- (viii) temporary closure and reconstruction of sections of the existing carriageways, footpaths and central median/traffic island; and
- (ix) ancillary works including construction of vehicular run-ins, drainage pipe and outfall, as well as water, sewerage, utilities and landscaping works.
