

RAILWAYS ORDINANCE (Chapter 519)

HONG KONG SECTION OF GUANGZHOU-SHENZHEN-HONG KONG
EXPRESS RAIL LINKAMENDMENT TO CREATION OF RIGHTS OF
TEMPORARY OCCUPATION OF LAND

TAKE NOTICE that under powers delegated by the Chief Executive, the Deputy Director/ Specialist, Lands Department has made an order under section 20(1) of the Railways Ordinance (Chapter 519) (hereinafter referred to as 'the Ordinance') and section 46 of the Interpretation and General Clauses Ordinance (Chapter 1) directing that the rights of temporary occupation of land created by the order referred to in Government Notice No. 545 dated 28 January 2010 (hereinafter referred to as 'the Original Order') as amended by Government Notice No. 3076 dated 30 May 2013 be further amended to the effect that in relation to the land more particularly described in the first column below as shown coloured purple stippled black hatched blue on Amendment to Creation of Rights of Temporary Occupation of Land Plan No. RDM1667 (hereinafter referred to as 'the Plan') annexed to the said order which land forms part of Lot No. 43 S.A RP (Portion) in Demarcation District No. 101 as shown coloured purple stippled black hatched blue on Creation of Rights of Temporary Occupation of Land Plan No. RDM1001 (Sheets 1 to 4) annexed to the Original Order as described in the scheme referred to in Government Notice No. 8022 published on 28 November 2008 and 5 December 2008 as amended and corrected by Government Notice No. 2598 published on 30 April 2009 and 8 May 2009, and as modified by Government Notice No. 6682 published on 30 October 2009 and 6 November 2009 and was authorized by the Chief Executive in Council and such authorization was gazatted in Government Notice No. 6682 published on 30 October 2009 and 6 November 2009, the period during which rights of temporary occupation of land have been created shall be amended as described in the second column below:—

Lot No. 43 S.A RP (Portion) and Lot No. 43 S.A ss. 2 (Portion) [formerly known as Lot No. 43 S.A RP (Portion)] both in Demarcation District No. 101 as shown coloured purple stippled black hatched blue on the Plan

From 29 April 2010 to 31 May 2015 instead of from 29 April 2010 to 31 October 2014
