OUTLYING ISLANDS SEWERAGE STAGE 2—
EXTENSION OF SEWERAGE SYSTEM TO OTHER UNSEWERED VILLAGES IN
MUI WO VILLAGE SEWERAGE WORKS AT LUK TEI TONG AND
MA PO TSUEN

(Notice under section 8(2) of the Roads (Works, Use and Compensation)
Ordinance as applied by section 26 of the Water Pollution
Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on the Plan No. 60027687/GAZ/9101A and the Resumption Plan No. ISM2282 (the 'Plans') and described in the scheme annexed thereto, which the Plans and the scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:—

- (i) Construction of approximately 2 900 metres of gravity sewer and associated manholes within the limit of works area as shown on the Plans;
- (ii) Construction of approximately 340 metres of twin pressurised mains and associated chambers within the limit of works area as shown on the Plans;
- (iii) Construction of 1 sewage pumping station at Luk Tei Tong within the limit of works area as shown on the Plans; and
- (iv) Ancillary works including temporary closure and reinstatement of roads, alleys, footpaths and open space.
