LANDFILL SITE (PHASE I)

(Amendment to Plan and Scheme under section 7)

(Notice under section 8(2) of the Roads (Works, Use and Compensation)
Ordinance as applied by section 26 of the Water Pollution
Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to amend the sewerage works originally described in the scheme and the Plans Nos. TK2322B, TK2323B and TK2324A referred to in G.N. 1568 published under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation on 14 March 2008 and 20 March 2008.

Take further notice that the Director of Environmental Protection proposes to execute the amendment sewerage works as shown on Amendment Plans Nos. TK2322C, TK2323C and TK2324B (the 'Amendment Plans') and described in the amendment scheme annexed thereto, which Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature of the amendment sewerage works is as follows:—

- (i) revisions of the limit of works areas as shown on the Amendment Plans;
- (ii) deletion of the originally proposed sewage overflow pipe;
- (iii) realignment of a section of the originally proposed twin rising mains, consequential deletion of sections of the originally proposed twin rising mains; and
- (iv) temporary closure and reconstruction of sections of the existing carriageways and footpaths/tracks.

The Amendment Plans and amendment scheme may be inspected by members of the public, free of charge, at the following locations and during the following hours when those offices are normally open to the public:—
