(Notice under section 8(2) of the Roads (Works, Use and Compensation)
 Ordinance as applied by section 26 of the Water Pollution
 Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan No. 231448/GAZ-C/001 (the 'Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:—

- (i) construction of rising mains, gravity sewers, sewage pumping stations and associated manholes within the limit of works area as shown on the Plan; and
- (ii) ancillary works including reinstatement of carriageways and footpaths affected.

The Plan and scheme may be inspected by members of the public, free of charge, at the following places and during the following hours when those offices are normally open to the public:—
