(Notice under section 8(2) of the Roads (Works, Use and Compensation)
Ordinance as applied by section 26 of the Water Pollution
Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plans Nos. 60022486/V/MN1 and 60022486/V/MN2 and Resumption Plan No. STM9536b (the 'Plans') and described in the scheme annexed thereto, which Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:—

- (i) Construction of approximately 1 200 meters of sewer and associated manholes within the limit of works area as shown on the Plans;
- (ii) Ancillary works including temporary closure and reinstatement of roads, alleys, footpaths and open spaces.
