NOTICE OF PREQUALIFICATION OF TENDERERS

It is intended to invite tenders in December 2015 from prequalified tenderers for Contract No. EP/SP/66/12 Integrated Waste Management Facilities, Phase 1. The tenders to be invited will be covered by the Agreement on Government Procurement of the World Trade Organisation and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organisation.

The scope of works of the contract comprises the design, construction, operation and maintenance of the Integrated Waste Management Facilities (IWMF) Phase 1 which will be on an artificial island near Shek Kwu Chau to treat 3 000 tons/day of municipal solid waste (MSW) by moving grate incineration technology. The design and construction of the artificial island shall also be part of the scope of works of the contract. The operation period for the IWMF Phase 1 will be 15 years, starting from the completion of the testing and commissioning of the IWMF Phase 1.

All applicants should read the Instructions to Applicants and the Prequalification Document and note in particular paragraphs 36 and 41 of the Instructions to Applicants. Applicants who are able to demonstrate that they have sufficient technical strength and experience in design, construction, operation and maintenance of municipal solid waste incineration facilities and with sound financial resources and meeting other qualifications and conditions for participation stipulated in the prequalification documents are invited to apply for prequalification.

A charge will be levied for delivery of the prequalification documents where the delivery of prequalification documents is requested by an applicant. A written request must be made.

Not more than four (4) applicants will be selected for tender invitations in accordance with the evaluation criteria stipulated in the prequalification documents.

Completed prequalification applications shall be submitted not later than 12.00 noon on Friday 12 June 2015 to Strategic Facilities Development and Planning Group, Nature Conservation and Infrastructure Planning Division, Environmental Protection Department at 3rd Floor, West Wing, Island West Transfer Station, 88 Victoria Road, Kennedy Town, Hong Kong. Late applications will not be accepted. If a black rainstorm warning signal or tropical cyclone signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on 12 June 2015, the closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone signal No. 8 is lowered.

Joint ventures satisfying the requirements stated in the prequalification documents will be considered.

The Government of the Hong Kong Special Administrative Region reserves the right to reject any application and to negotiate with any applicants about the terms of their offers.
