NOTICE OF PREQUALIFICATION OF TENDERERS

It is intended to invite tenders in the December of 2015 from prequalified tenderers for Contract No. EP/SP/77/15 Northeast New Territories Landfill Extension. The tenders to be invited will be covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The scope of works of the contract comprises the design, construction, operation, aftercare and restoration of the Northeast New Territories Landfill Extension at Ta Kwu Ling, New Territories, Hong Kong Special Administrative Region (HKSAR). The contract includes design and initial works of 2 years, phased development and operation to fill up the landfill capacity of 19Mm<sup>3</sup>, the operation period is estimated to be about 10 years, restoration works of 2 years, and aftercare for the landfill for a period of 30 years.

Applicants who are able to demonstrate that they have sufficient technical strength and experience in design, construction, operation, aftercare and restoration of landfill and with sound financial resources and meeting other qualifications and conditions for participation stipulated in the prequalification documents are invited to apply for prequalification. All applicants should read the Instructions to Applicants and the Prequalification Documents.

A charge will be levied for delivery of prequalification documents requested by an applicant. A written request must be made for such delivery.

Not more than four (4) applicants will be selected for tender invitations in accordance with the evaluation criteria stipulated in the prequalification documents. A two-stage evaluation process will be adopted for the prequalification. The first stage is to determine whether an applicant satisfies the basic requirements and the second stage is a detailed assessment on (i) experience records, (ii) past performance, (iii) technical resources and (iv) proposal for undertaking the project of the applicant who satisfies the first stage assessment. The criteria for the two-stage evaluation are given in the prequalification documents.

Completed prequalification applications shall be submitted not later than 12.00 noon on Friday, 31 July 2015 to Landfills and Development Group, Environmental Infrastructure Division, Environmental Protection Department at 2nd Floor, West Wing, Island West Transfer Station, 88 Victoria Road, Kennedy Town, Hong Kong. Late applications will not be accepted. If a black rainstorm warning signal or tropical cyclone signal No. 8 or above is hoisted at any time between 9.00 a.m. and 12.00 noon on 31 July 2015, the closing time will be postponed to 12.00 noon of the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone signal No. 8 is lowered.

Joint ventures satisfying the requirements stated in the prequalification documents will be considered.

The Government of Hong Kong Special Administrative Region reserves the right to reject any application and to negotiate with any applicants about the terms of their offers.
