PWP ITEM NO. 7771CL DEVELOPMENT OF EX-CHA KWO LING KAOLIN MINE SITE

(Notice under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation)

Notice is hereby given that the Director of Environmental Protection proposes to execute the sewerage works within the limit of works area as shown on Plan No. GAZ/401 (the 'Plan') and described in the scheme annexed thereto, which Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed sewerage works is as follows:----

- (i) construction of about 700 meters of gravity sewers and associated manholes within the limit of works area as shown on the Plan; and
- (ii) ancillary works including reinstatement of carriageways, footpaths and open space.
