Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. CE53/NF40/GZ/0001 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:----

- (i) construction of two lifts at the existing footbridge No. NF40 near Wo Che Street in Sha Tin District;
- (ii) construction of elevated platforms to connect the proposed lifts in (i) with the existing footbridge No. NF40;
- (iii) permanent closure and conversion of a section of the existing carriageway into part of the proposed lift in (i) and footpath;
- (iv) permanent closure and conversion of a section of the existing footpath into part of the proposed lift in (i);
- (v) permanent closure and conversion of an existing staircase into one of the proposed lifts in (i), one of the elevated platforms in (ii) and footpath;
- (vi) permanent closure and conversion of a section of the existing amenity area into footpath; and
- (vii) ancillary works including electrical and mechanical, drainage and lighting works.
