

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1149EM15T—42-Month Term Contract for the Fault Attendance, Comprehensive Maintenance, Repair and Replacement of Special Lighting Systems at Various Premises of the Highways Department of the Government of the Hong Kong Special Administrative Region.**

The scope of works includes the provision of fault attendance, preventive maintenance, corrective maintenance and replacement services on special lighting works, such as subway, footbridge, walkway, ferry concourse and tram shelter lighting installations. The works are expected to commence in February 2016 for completion in July 2019.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to 'The Chairman, Central Tender Board' and placed in the 'Government Logistics Department Tender Box' which is located on the Ground Floor, North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon, Friday, 8 January 2016. Late tenders will not be accepted.
