

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1608EM15T—Biennial Term Contract for the Comprehensive Maintenance and Repair of Lift Installations at Various Premises of the Government of the Hong Kong Special Administrative Region and Hospital Authority (Package One of AE15)**. The scope of works for this contract includes comprehensive maintenance and repair of lift installations at various premises of the Government of the Hong Kong Special Administrative Region and Hospital Authority. The works are scheduled to commence in April 2016 for completion in March 2018.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Logistics Department Tender Box located on Ground Floor, North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 8 January 2016. Late tenders will not be accepted.

Open tendering is adopted. Contractors who meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (A) Contractor must be a registered lift contractor under the Lifts and Escalators Ordinance (Chapter 618 of the Laws of Hong Kong); and
- (B) Contractor must have completed lift maintenance contracts in or outside Hong Kong within the past 5 years with the minimum accumulated awarded contract sum of not less than HK\$40 million.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept any tender irrespective of whether the tender is the lowest bid or where the assessment of tenders is based on a marking scheme or formula approach, the tender with the highest overall score.
