

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1364EM15T—Quadrennial Term Contract for Provision of Maintenance and Modification Works of Traffic Control and Surveillance System for Hong Kong—Shenzhen Western Corridor, Deep Bay Link and Yuen Long Highway.**

The scope of works includes maintenance and modification works for the Traffic Control and Surveillance System for Hong Kong—Shenzhen Western Corridor, Deep Bay Link and Yuen Long Highway. The Contract is expected to commence in March 2016 for completion in March 2020.
