

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1043EM15T—Triennial Term Contract for FM200 Cylinders Hydraulic Test at Hong Kong International Airport**. The works include provision of hydraulic test of FM200 cylinders at various airport venues and outlying islands. The works are scheduled to commence in February 2016 for completion in January 2019.
