

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF SHEUNG FUNG STREET,
YUK WAH STREET, WAN WAH STREET, WAI WAH STREET,
PO KONG VILLAGE ROAD AND TSZ WAN SHAN ROAD;
PART OF TSZ WAN SHAN ROAD REST GARDEN, AND
PART OF TSZ WAN SHAN ESTATE CENTRAL PLAYGROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 18 December 2015 (the 'Order'), authorized:-

- (I) (a) the temporary partial closure of the section of Sheung Fung Street between its junction with Wan Wah Street and a point about 50 metres west of the junction, as delineated and shown in purple on the Plan numbered SCL/G10/0009/4;
- (b) the temporary partial closure of the section of Yuk Wah Street between its junction with Wan Wah Street and a point about 170 metres east of the junction, as delineated and shown in beige on the Plan numbered SCL/G10/0009/4; and
- (c) the temporary partial closure of the section of Wan Wah Street between its junction with Sheung Fung Street and a point about 15 metres south of the junction, as delineated and shown in brown on the Plan numbered SCL/G10/0009/4,
- during the period from 21 January to 31 March 2016;
- (II) the temporary closure of part of Tsz Wan Shan Road Rest Garden, as delineated and shown in pink on the Plan numbered SCL/G10/0009/4 during the period from 21 January to 29 July 2016;
- (III) the temporary closure of part of Tsz Wan Shan Estate Central Playground, as delineated and shown in dark blue on the Plan numbered SCL/G10/0009/4 during the period from 21 January to 28 November 2016; and
- (IV) (a) the temporary partial closure of the section of Wan Wah Street between its junction with Tsz Wan Shan Road and a point about 190 metres south of the junction, and the section of Wan Wah Street between a point about 120 metres north of its junction with Yuk Wah Street and a point about 60 metres south of the junction, both delineated and shown in dark green on the Plan numbered SCL/G10/0009/4;

- (b) the temporary partial closure of the section of Wai Wah Street between its junction with Wan Wah Street and a point about 30 metres east of the junction, and the section of Po Kong Village Road between a point about 60 metres west of its junction with Tsz Wan Shan Road and a point about 30 metres east of the junction, as delineated and shown in red and light blue respectively on the Plan numbered SCL/G10/0009/4; and
- (c) the temporary partial closure of the section of Tsz Wan Shan Road between a point about 60 metres southeast of its junction with Ching Fai Street and a point about 190 metres northwest of the junction, and the section of Tsz Wan Shan Road between its junction with Po Kong Village Road and a point about 130 metres north of the junction, both delineated and shown in orange on the Plan numbered SCL/G10/0009/4,

during the period from 21 January 2016 to 20 January 2017,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads and the areas of Tsz Wan Shan Road Rest Garden and Tsz Wan Shan Estate Central Playground to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G10/0009/4 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the roads, Tsz Wan Shan Road Rest Garden and Tsz Wan Shan Estate Central Playground affected by the Order on 31 December 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads, Tsz Wan Shan Road Rest Garden and Tsz Wan Shan Estate Central Playground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads, Tsz Wan Shan Road Rest Garden and Tsz Wan Shan Estate Central Playground affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads, Tsz Wan Shan Road Rest Garden and Tsz Wan Shan Estate Central Playground or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

- (i) The section of Tsz Wan Shan Road between a point about 60 metres southeast of its junction with Ching Fai Street and a point about 190 metres northwest of the junction, and the section of Tsz Wan Shan Road between its junction with Po Kong Village Road and a point about 130 metres north of the junction, both delineated and shown in orange on the Plan numbered SCL/G10/0009/4.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the pedestrian walkway systems near Tsz Wan Shan Estate Central Playground and at Yuk Wah Street in relation to the Shatin to Central Link.
