- (iv) realignment of a section of the proposed noise barrier under PWP Item No. 6720TH;
- (v) relocation of refuge islands under PWP Item No. 6720TH;
- (vi) permanent closure and conversion of a section of the existing cycle track into footpath;
- (vii) temporary closure of sections of the existing carriageways, footpaths and cycle track; and (viii) associated utility services works.

Under Civil Engineering and Development Department's 'PWP Item No. 7747CL-Advance Site Formation and Engineering Infrastructure Works at Kwu Tung North New Development Area and Fanling North New Development Area (Road Works)' ('PWP Item No. 7747CL'), permanent closure and relocation of the Proposed BBI to a nearby location, and associated modification of the other proposed works as shown in the Plan and described in the scheme annexed thereto are proposed, details of which are shown on Plan No. 60335576/GZ1/113 and described in the scheme annexed thereto.
