

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1368EM15T—Triennial Term Contract for the Maintenance and Repair of, Alterations and Additions to, Fire Service Installations for Venues of Transport Department, Highways Department and Drainage Services Department.**

The scope of works includes maintenance, repair, alteration and additional services of fire service installations for the venues of the Transport Department, the Highways Department and the Drainage Services Department. The Contract is scheduled to commence in July 2016 for completion in June 2019.
