

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2402EM15T—Triennial Term Contract for the Maintenance and Repair of Burglar Alarm and Security Installations at Various Premises of the Government of the Hong Kong Special Administrative Region and Hospital Authority (Health Sector Division, Municipal Sector Division and Transport, Security and Central Services Division—Package 2A)**. The Works shall include the inspection, examination, testing, adjustment, fully comprehensive servicing and maintenance of existing Burglar Alarm and Security Installations at various premises of the Government of the Hong Kong Special Administrative Region and Hospital Authority and other works and services specified in the contract. This contract is scheduled to commence in May 2016 for completion in April 2019.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Logistics Department Tender Box situated in Ground Floor, North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 4 March 2016. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 4 March 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered.

Selective tendering is adopted. Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Burglar Alarm and Security Installation, or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Burglar Alarm and Security Installation, who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (A) The tenderer shall have completed maintenance contracts for security systems with a total aggregate contract value of not less than HK\$19.8 million within the 5-year period immediately preceding the tender closing date specified in the Letter of Invitation to Tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement; and
- (B) The tenderer or the lead participant/major shareholder of the joint venture must be on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Burglar Alarm and Security Installation.
