

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF WAN WAH STREET,
YUK WAH STREET AND SHEUNG FUNG STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 March 2016 (the ‘Order’), authorized:–

- (I) the temporary partial closure of the section of Wan Wah Street between its junction with Sheung Fung Street and a point about 15 metres south of the junction, as delineated and shown in brown on the Plan numbered SCL/G10/0009/5 during the period from 1 April to 10 June 2016;
- (II) the temporary partial closure of the section of Yuk Wah Street between its junction with Wan Wah Street and a point about 170 metres east of the junction, as delineated and shown in beige on the Plan numbered SCL/G10/0009/5 during the period from 1 April to 30 September 2016; and
- (III) the temporary partial closure of the section of Sheung Fung Street between its junction with Wan Wah Street and a point about 50 metres west of the junction, as delineated and shown in purple on the Plan numbered SCL/G10/0009/5 during the period from 1 April 2016 to 20 January 2017,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
