

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

CYCLE TRACK BETWEEN TSUEN WAN AND TUEN MUN (ADVANCE WORKS)

*Amendments under section 7*

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to amend the works originally shown on Plans Nos. NTN 2301 and NTN 2302 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 4999 published under section 8(2) of the Ordinance on 27 July 2012 and 3 August 2012. The proposed amendments are shown on Amendment Plans Nos. NTN 2301A and NTN 2302A ('the Amendment Plans') and described in the amendment scheme annexed thereto, which the Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature of the proposed amendments is as follows:—

- (i) revision of the originally proposed limit of works area;
- (ii) revision of the alignment of the originally proposed two-way cycle track and associated footpaths;
- (iii) revision of the extent of the originally proposed entry/exit hub and the locations of the two originally proposed resting stations;
- (iv) deletion of sections of the originally proposed cycle track, footpaths, parts of the originally proposed resting stations and entry/exit hub;
- (v) deletion of the originally proposed permanent closure and conversion of a section of the existing footpath into cycle track;
- (vi) deletion of the originally proposed permanent closure and conversion of a section of the existing footpath into entry/exit hub;
- (vii) deletion of parts of the originally proposed entry/exit hub, and replaced by proposed cycle track;
- (viii) deletion of sections of the originally proposed cycle track, and replaced by proposed footpaths;
- (ix) deletion of sections of the originally proposed cycle track, and replaced by proposed entry/exit hub;
- (x) deletion of the originally proposed permanent closure and conversion of a section of the existing footpath into cycle track, and replaced by permanent closure and conversion of a section of the existing footpath into entry/exit hub;
- (xi) deletion of the originally proposed permanent closure and conversion of sections of the existing footpath into cycle track, and replaced by temporary closure and reconstruction of sections of the existing footpaths;
- (xii) deletion of the originally proposed retaining wall, and replaced by modification of the existing seawall;
- (xiii) construction of footpath connecting Wing Shun Street;
- (xiv) construction of a lift, associated platform and staircase at an existing footbridge across Hoi On Road near Belvedere Garden Phase 3;
- (xv) permanent closure and conversion of sections of the existing footpaths into cycle track and amenity area;
- (xvi) permanent closure and conversion of sections of the existing footbridge ramp and staircase across Hoi On Road near Belvedere Garden Phase 3 into cycle track;
- (xvii) permanent closure and demolition of sections of the existing footbridge ramp and staircase across Hoi On Road near Belvedere Garden Phase 3;
- (xviii) temporary closure and reconstruction of sections of the existing footpath;

- (xix) temporary closure of sections of the existing footpaths; and
- (xx) revision of the proposed ancillary works including water, drainage, sewerage, geotechnical, utilities, street lighting and landscaping works, and installation of traffic aids.

The Amendment Plans and amendment scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Objectors are requested to provide contact details to the Secretary to facilitate communication.

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided.
