

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2664EM15T—Triennial Term Contract for Maintenance of Electrical and Mechanical Installations at Hong Kong Wetland Park**. The works shall include maintenance, repair, alterations and additions to the electrical and mechanical installations at Hong Kong Wetland Park. This Contract is scheduled to commence in Sept 2016 for completion in Aug 2019.

Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Air-conditioning Installation (Group II), or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Air-conditioning Installation (Group II), who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

(A) The tenderer shall have completed maintenance and repair contracts for Air-conditioning installation with a total aggregate contract value of not less than HK\$7.2 million within the 5-year period immediately preceding the tender closing date specified in the Letter of Invitation to Tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement; and

(B) The tenderer or the lead participant/major shareholder of the joint venture must be on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Air-conditioning Installation (Group II).
