

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. HY/2015/06—Provision of Barrier-free Access Facilities for Highway Structures—Phase 3 Contract 8**. The works include construction of 14 lifts for 6 existing footbridges and 2 existing subways in North District, Sha Tin District, Tai Po District and Yuen Long District, construction of associated civil works, geotechnical works, electrical and mechanical works, modification works for existing structures, road and drainage works, landscaping works, etc. The works are scheduled to commence in August 2016 and will take about 36 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 29 April 2016. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 29 April 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered.

Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C for Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C for Roads and Drainage Category, who also meet the following qualifications and conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer must have completed at least one (1) civil engineering contract involving road and drainage works and temporary traffic arrangements with awarded contract sum of not less than HK\$100 million, in or outside Hong Kong, within the past 8 years.

Contractors not yet on the List of Approved Contractors for Public Works in Group C for Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 12 April 2016 to Chief Engineer 1/Major Works, Major Works Project Management Office, at 6th Floor, Ho Man Tin Government Offices, 88 Chung Hau Street, Ho Man Tin, Kowloon, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
