

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

ROAD WORKS UNDER PWP ITEM NO. 776CL (PART)
SITE FORMATION AND INFRASTRUCTURE WORKS FOR DEVELOPMENT
AT KAM TIN SOUTH, YUEN LONG

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. 60336159/GAZ1/100, 60336159/GAZ1/101, 60336159/GAZ1/102, 60336159/GAZ1/103, 60336159/GAZ1/104 and 60336159/GAZ1/105 ("the Plans") and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) widening of a section of Kam Ho Road between Kam Tin Road and Tung Wui Road from a single two-lane carriageway to a dual two-lane carriageway;
- (ii) modification of the existing junctions of Kam Tin Road/Kam Ho Road and Kam Tin Road/Kam Sheung Road;
- (iii) construction of bus laybys along Kam Sheung Road;
- (iv) modification of the existing junction of Tung Wui Road and Kam Sheung Road;
- (v) modification of the existing junctions of Pat Heung Road/ Pat Heung Road slip road and Pat Heung Road/ Tsing Long Highway slip road;
- (vi) modification of the existing junction of Pat Heung Road/ Kam Sheung Road;
- (vii) construction of at grade carriageways, elevated carriageway, at grade footpaths, elevated footpath, cycle tracks, central reserves/refuge islands, verges, pedestrian crossings, run in/ run out and noise barriers;
- (viii) permanent closure and conversion of sections of the existing at grade carriageways into at grade footpaths, central reserves/refuge islands, verges and pedestrian crossings;
- (ix) permanent closure and conversion of sections of the existing at grade footpaths into at grade carriageways, central reserves /refuge islands, cycle tracks and verges;
- (x) permanent closure and conversion of sections of the existing elevated footpath into central reserve/refuge island;
- (xi) permanent closure and conversion of sections of the existing cycle tracks into at grade carriageways, at grade footpaths, verges and pedestrian crossing;
- (xii) permanent closure and conversion of sections of the existing central reserves/refuge islands into at grade carriageways, at grade footpaths, verge and pedestrian crossings;
- (xiii) permanent closure and conversion of sections of the existing verges into at grade carriageways, at grade footpaths, central reserves/refuge islands and cycle tracks;
- (xiv) permanent demolition and conversion of sections of the existing noise barriers into cycle tracks;
- (xv) modification of the existing run ins/run outs;
- (xvi) temporary closure and modification of sections of the existing at grade carriageways, elevated carriageways, at grade footpaths, elevated footpaths, central reserves/refuge islands, verges and cycle tracks;
- (xvii) temporary closure of sections of the existing at grade carriageways, elevated carriageways, at grade footpaths, elevated footpaths, cycle tracks, central reserves/refuge islands and verges; and
- (xviii) ancillary works including landscaping, waterworks, drainage, sewerage, utilities, lighting, electrical and mechanical works, and construction of retaining walls and slopes.
