TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing vehicular bridges, at-grade carriageways, footpaths and cycle tracks within the limit of works area as shown on Plans Nos. HyD/TFH/GZ/001 to HyD/TFH/GZ/008 ('the Plans') and described in the scheme annexed thereto, and as modified by Modification Plan No. HyD/TFH/GZ/008A ('the Modification Plan'). The Plans and scheme were referred to in G.N. 6868 published on 26 October 2007 and 2 November 2007. The Modification Plan was referred to in G.N. 4241 published on 27 June 2008 and 4 July 2008. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 1 April 2016 to 31 March 2017, all public or private rights in, upon, under or over the sections of the existing vehicular bridges, at-grade carriageways, footpaths and cycle tracks to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the remaining works for the following items: widening of the section of Tolo Highway between Island House Interchange and Tai Hang from dual 3-lane carriageway to dual 4-lane carriageway and other ancillary works.

A copy of the order, the Plans and the Modification Plan may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected vehicular bridges, at-grade carriageways, footpaths and cycle tracks on 24 March 2016.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.
