

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

PWP CATEGORY D ITEM  
 UNIVERSAL ACCESSIBILITY PROGRAMME—  
 PROVISION OF LIFT AT FOOTBRIDGE NO. HF85  
 AT THE JUNCTION OF YEE WO STREET, PENNINGTON STREET  
 AND SUGAR STREET IN WAN CHAI DISTRICT

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently an existing staircase and elevated platform; and temporarily sections of the existing carriageways and footpaths within the limit of works area as shown on Plan No. CE58/GAZ/HF85/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 3917 published on 11 July 2014 and 18 July 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 9 April 2016, all public or private rights in, upon, under or over the existing staircase and elevated platform to be permanently closed, shall be extinguished; and from 9 April 2016 to 8 April 2017, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a lift at the existing footbridge No. HF85 at the Junction of Yee Wo Street, Pennington Street and Sugar Street, the construction of an elevated platform to connect the proposed lift with the existing footbridge and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, staircase and elevated platform on 1 April 2016.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.
