Late tenders will not be accepted. If a Black Rainstorm Warning Signal or Tropical Cyclone Warning Signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon (Hong Kong time) on the closing date of the tender as stated above, the tender closing time will be postponed to 12.00 noon (Hong Kong time) on the first working day after the Black Rainstorm Warning Signal has ceased to be in effect or the Tropical Cyclone Warning Signal No. 8 is lowered.
