**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF SECTIONS OF CHATHAM ROAD NORTH AND  
WINSLOW STREET, AND A FOOTPATH BETWEEN  
CHATHAM ROAD NORTH AND OI SEN PATH; AND  
TEMPORARY ALTERATION OF SECTIONS OF OI SEN PATH AND  
CHATHAM ROAD NORTH, AND SLIP ROADS FROM HONG CHONG ROAD  
TO CHATHAM ROAD NORTH, FROM WINSLOW STREET TO  
CHATHAM ROAD NORTH, FROM CHATHAM ROAD NORTH TO  
HONG CHONG ROAD AND CHEONG TUNG ROAD SOUTH, AND  
FROM CHATHAM ROAD NORTH TO HONG CHONG ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 13 April 2016 (the ‘Order’), authorized:–

- (I) (a) the temporary partial closure of the section of Chatham Road North (and its adjacent staircase) between its junctions with Bulkeley Street and Wa Fung Street, as delineated and shown in red on the Plans numbered SCL/G26/0019/4 and SCL/G27/0019/4; and
- (b) the temporary closure of the section of Chatham Road North near its junctions with Wa Fung Street and Winslow Street, as delineated and shown in brown on the Plan numbered SCL/G27/0019/4,
- during the period from 10 May to 31 December 2016; and
- (II) (a) the temporary partial closure of the section of Winslow Street between Chatham Road North and Lo Lung Hang Street, as delineated and shown in blue on the Plan numbered SCL/G27/0019/4;
- (b) the temporary closure of the footpath between Chatham Road North and Oi Sen Path, as delineated and shown in dark green on the Plans numbered SCL/G26/0019/4 and SCL/G27/0019/4;
- (c) the temporary alteration of the section of Oi Sen Path (and its pedestrian subways) between its junction with Winslow Street and a point about 480 metres northwest of the junction, as delineated and shown in green on the Plans numbered SCL/G26/0019/4 and SCL/G27/0019/4;
- (d) the temporary alteration of the section of Chatham Road North between its junction with Chatham Road South and a point about 20 metres northeast of its junction with Bulkeley Street, as delineated and shown in beige on the Plans numbered SCL/G26/0019/4 and SCL/G27/0019/4;

- (e) the temporary alteration of the slip roads from Hong Chong Road to Chatham Road North, and from Winslow Street to Chatham Road North, as delineated and shown in purple and orange respectively on the Plans numbered SCL/G26/0019/4 and SCL/G27/0019/4; and
- (f) the temporary alteration of the slip roads from Chatham Road North to Hong Chong Road and Cheong Tung Road South, and from Chatham Road North to Hong Chong Road, as delineated and shown in yellow and dark blue respectively on the Plan numbered SCL/G27/0019/4,

during the period from 10 May 2016 to 9 May 2017,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads, the staircase, the footpath and the pedestrian subways to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the roads, the staircase, the footpath and the pedestrian subways affected by the Order on 22 April 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure/alteration of the relevant part or parts of the roads, the staircase, the footpath and the pedestrian subways or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads, the staircase, the footpath and the pedestrian subways affected by the Order.

Notice is hereby given that further closure/alteration of the same part or parts of the roads, the staircase, the footpath and the pedestrian subways or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.
