

**RAILWAYS ORDINANCE (Chapter 519)  
(Notice under section 23)**

**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF SECTIONS OF  
TSZ WAN SHAN ROAD AND WAN WAH STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 29 April 2016 (the ‘Order’), authorized:–

- (I) the temporary partial closure of the section of Tsz Wan Shan Road between Wai Wah Street and Lok Wah Street, as delineated and shown in orange on the Plan numbered SCL/G10/0058/1 during the period from 31 May 2016 to 30 May 2017; and
- (II) the temporary closure of the section of Wan Wah Street between its junction with Sheung Fung Street and a point about 15 metres south of the junction, as delineated and shown in brown on the Plan numbered SCL/G10/0058/1, with details as follows:
  - (a) (i) from 11:00 p.m. to 5:00 a.m. during the period of 11 June to 16 August 2016; and (ii) from 1:30 a.m. to 5:00 a.m. during the period of 17 to 23 August 2016, with all carriageway and footpath widths of the section of the road closed; and
  - (b) during the period from 11 June to 30 September 2016, except the periods specified in (II)(a) above, with parts of the carriageway and footpath widths of the section of the road closed,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G10/0058/1 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the roads affected by the Order on 13 May 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
