TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, central medians/ refuge islands and amenity areas within the limit of works area as shown on Plans Nos. 24037/GZ/012 to 24037/GZ/016 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 4890 published on 7 August 2009 and 14 August 2009. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 31 May 2016 to 30 May 2017, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central medians/ refuge islands and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of a tunnel at Scenic Hill, an elevated expressway connecting the proposed Hong Kong-Zhuhai-Macao Bridge (HZMB) Main Bridge with the proposed tunnel at Scenic Hill, an at-grade expressway connecting the proposed tunnel at Scenic Hill with the proposed internal roads of the proposed HZMB Hong Kong Boundary Crossing Facilities, ventilation facilities and associated tunnel operation and maintenance facilities to the proposed tunnel at Scenic Hill and other ancillary works.
