I am of the opinion that the building known as <u>Portion Of External</u> Wall Of Shun Fat Building Nos. 445 - 449 Shun Ning Road Kowloon on N.K.I.L. 2711 s.B ss.6 R.P., N.K.I.L. 2711 s.B R.P. & N.K.I.L. 2711 s.G R.P. is liable to become dangerous.

2. In exercise of the powers vested in me by section 26 of the Buildings Ordinance, I HEREBY DECLARE that such building is liable to become dangerous and I HEREBY ORDER you as owner to carry out the following works and such works are to be commenced by <u>26 May 2016</u> and to be completed by <u>9 June 2016</u>:

For external walls of the building only:

- (i) remove loose, cracked, defective concrete, clean exposed rusty steel bars, replace or add steel bars as necessary, and reinstate with new concrete; and
- (ii) remove all loose, defective rendering.

All works specified in this order shall be carried out to such standard acceptable to the Building Authority and in compliance with the regulations.

3. Section 46 of the Interpretation and General Clauses Ordinance (Cap. 1) provides, inter alia, that where any Ordinance confers power upon any person to make any order, such power shall include power to substitute another order for the one already made. Pursuant to that section, the Building Authority who is empowered under section 26 of the Buildings Ordinance (Cap. 123) to make the previous orders i.e. Order No. <u>D00025/K/16</u> dated <u>25 January 2016</u> is also empowered to make this order which substitutes the previous orders.
