

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DC/2015/05—Minor Drainage Improvement Works in Northern Hong Kong Island and North District**. The works include minor improvement works for stormwater drainage and sewerage systems at 18 locations in Wan Chai, Central and Western, North and Yuen Long Districts. The works are scheduled to commence in August 2016 for completion in February 2020.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor of North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 8 July 2016. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 8 July 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.
