

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. CV/2016/02 Road and Infrastructure Works for Development at Lin Cheung Road, Sham Shui Po**. The works include the construction of a single two-lane carriageway with footpaths, a pedestrian walkway at the eastern boundary of the site leading to Nam Cheong MTR Station, and ancillary works including drainage, waterworks, sewerage, retaining wall and landscaping works. The works are scheduled to commence in September 2016 and will take about 19 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box in Room 4128f, 41st, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 29 July 2016. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 29 July 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Contractors on the List of Approved Contractors for Public Works in Group B under Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group B under Roads and Drainage Category.

Contractors not yet on the List of Approved Contractors for Public Works in Group B under Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list by 4 July 2016 to Deputy Head (Project and Environmental Management), Civil Engineering Office, Civil Engineering and Development Department at 3rd Floor, Civil Engineering and Development Building, 101 Princess Margaret Road, Ho Man Tin, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
