

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DE/2016/04—Term Contract for Waste Disposal and Minor Civil Engineering Works for Various Sewage Treatment Plants and Pumping Stations in Urban Area, Lantau Island and Outlying Islands**. The works include disposal of wastes, maintenance, cleaning and minor civil engineering works at various sewage treatment plants and pumping stations in Urban Area, Lantau Island and Outlying Islands for thirty-six (36) months. The works are scheduled to commence in December 2016 for completion in November 2019.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box located on the ground floor of North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 29 July 2016. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 29 July 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Contractors on the List of Approved Contractors for Public Works under the Category of Roads and Drainage in Group B or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works under the Category of Roads and Drainage in Group B who also meet the qualifications and conditions for participation stipulated in the tender documents are invited to tender.

Contractors not yet on the List of Approved Contractors for Public Works under the Category of Roads and Drainage in Group B may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by Friday, 15 July 2016 to Chief Engineer/Sewage Treatment 2, Sewage Treatment Division 2, Drainage Services Department at 2nd Floor, Administration Building, Stonecutters Island Sewage Treatment Works, Ngong Shung Road, Ngong Shuen Chau, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
