

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

 RIVER SILVER, MUI WO, LANTAU ISLAND

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily a section of the existing carriageway and cycle track, and sections of the existing footpaths and amenity area within the limit of works area as shown on Plan No. 3181/G/001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 2974 published on 4 May 2012 and 11 May 2012. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 12 July 2016 to 11 July 2017, all public or private rights in, upon, under or over the section of the existing carriageway and cycle track, and sections of the existing footpaths and amenity area to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a footpath along the waterfront between Mui Wo Cooked Food Market and River Silver, a footbridge across River Silver and amenity areas; as well as ancillary works.

This notice will be affixed on or near the affected carriageway, footpaths, cycle track and amenity area on 30 June 2016.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before the expiration of one year from the date of closure.
