

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

PWP ITEM NO. 7259RS (PART)—CYCLE TRACKS CONNECTING NORTH WEST
NEW TERRITORIES WITH NORTH EAST NEW TERRITORIES—
SECTION FROM TUEN MUN TO SHEUNG SHUI

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing roads, footpaths/staircases, tracks and bus lay-by; and temporarily sections of the existing roads, footpaths/staircases, cycle tracks and tracks within the limit of works area as shown on Plans Nos. NTN2219 (only includes limit of works area from chainage CH-MP1+110m to CH-MP1+800m shown on the Plan), NTN2220 to NTN2225, NTN2226 (only includes limit of works area from chainage CH-KW3+715m to CH-KW3+950m shown on the Plan) ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. NTN2222A, NTN2223A and NTN2224A ('the Amendment Plans') and described in the amendment scheme annexed thereto, and as modified by Modification Plan No. NTN2221A, NTN2225A and NTW-W3-1 ('the Modification Plans'), and as further amended by Second Amendment Plans Nos. NTN2221B, NTN2222B, NTN2226A, NTN2300 and NTW-W3-1A ('the Second Amendment Plans') and described in the second amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 3720 published on 6 June 2008 and 13 June 2008. The Amendment Plans and amendment scheme were referred to in G.N. 2600 published on 30 April 2009 and 8 May 2009. The Modification Plans were referred to in G.N. 211 published on 15 January 2010 and 22 January 2010. The Second Amendment Plans and second amendment scheme were referred to in G.N. 5492 published on 26 September 2014 and 3 October 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 16 July 2016, all public or private rights in, upon, under or over the sections of the existing roads, footpaths/staircases, tracks and bus lay-by to be permanently closed, shall be extinguished; and from 16 July 2016 to 15 July 2017, all public or private rights in, upon, under or over the sections of the existing roads, footpaths/staircases, cycle tracks and tracks to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of sections of cycle tracks along Kam Tin River, Ngau Tam Mei Drainage Channel, Castle Peak Road, San Tam Road, San Tin Highway, Mai Po Lung Road, Shek Wu Wai Road, Sheung Yue River and Shek Sheung River, and modification of associated roads and footpaths; construction of sections of roads, footpaths/staircases, bus lay-by and bridge/ramps; construction of cycle tracks with associated facilities including cycle parking and resting stations; and ancillary works including water, drainage, sewerage, geotechnical and landscaping works, construction of retaining structures and installation of traffic aids.

This notice will be affixed on or near the affected roads, footpaths/staircases, tracks, bus lay-by and cycle tracks on 15 July 2016.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims served under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is obligatory. If such information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
